Amir Peay is the re-founder, sole owner and operator of the James E. Pepper Distillery in Lexington, Kentucky.

Peay got an early start in the beverage alcohol business, via his early and multiple jobs in the restaurant and bar industry. As a former bartender, he learned first-hand the needs and motivations of the customers who now enjoy his products.

A student of philosophy, he later developed a deep appreciation for both American history and whiskey. These pursuits led him to discover the lost legacy of the iconic Pepper whiskey brand and distillery, both of which had been abandoned for over 50 years. Intrigued by the rich history, Peay was able to acquire the rights to the brand in 2008 and embarked upon a decade long

campaign of thorough historical research and collection of historic materials. A vast amount of information and materials were assembled so that the brand could be re-launched in a proper fashion.

Peay initially partnered with existing distilleries to relaunch the brand under the James E. Pepper "1776" label, then built it into an award-winning product distributed around the world. The success of the 1776 label allowed him to build an independent whiskey company, which in turn allowed him to fulfill a years-long mission to rebuild the abandoned and historic James E. Pepper Distillery in Lexington, Kentucky. The distillery re-commenced production in December of 2017 using the original bourbon last used at the distillery when it ceased production in 1961.



Anne Sabatino Hardy

Anne Sabatino Hardy is the executive director of Visit Horse Country, a not-for-profit organization dedicated to fan development through experiences at equine-related attractions throughout the Commonwealth of Kentucky. His reform of the police and fire pension system preserved the retirements of more than 1,000 retirees while saving the city millions. Those savings allowed Mayor Gray to invest in public

In his second term, Lexington's economy grew quickly thanks to low unemployment and a thriving tech sector. Gray worked to drive growth in high-paying sectors through the city's first job-creation fund. To further nurture the creativity and entrepreneurship growing out of the University of Kentucky, Gray attracted private investment to make Lexington the nation's largest gigabit city through the creation of a fiber-optic network, also providing cable TV competition.

The revitalization of Lexington's booming downtown continues today with renovation of The Historic Courthouse and construction underway for Town Branch Commons. The Commons will wind through downtown, following the path of Lexington's original water source, Town Branch. There are also plans for the creation of Town Branch Park through a public-private partnership. Complementing Town Branch, the reinvention of Rupp Arena and an expansion of the Convention Center are also underway, marking the single largest public capital public improvement project in Lexington's history.

Gray received a B.A. from Vanderbilt University before returning home to help grow his family's construction firm, accepting a Loeb Fellow appointment at Harvard along the way. Today, he is chairman of the board of Gray Construction, one of the country's largest builders of manufacturing, distribution, automotive and food & beverage facilities, for which he formerly served as CEO. The company has annual revenues over \$1 billion and projects completed for companies like BMW, Toyota, Clemens Food Group and Amazon.

This program is designed to ensure each UK team is No. 1 or wins a conference or national championship, sustain a department-wide 3.0 grade-point average and rank in the top five of the Learfield IMG Directors' Cup standings by 2022. Four UK teams have won championships towards Elite 1-3-5, while the school's six best Directors' Cup finishes have come in the last seven seasons and Wildcat student-athletes on scholarship have

combined for a GPA of better than 3.0 in 14 consecutive semesters.

Barnhart is influential on the national level. He has served on numerous committees and boards for the NCAA and the National Association of Collegiate Directors of Athletics (NACDA) and completed his third year as a member of the NCAA Division I Men's Basketball Committee in 2019. He has also served on the NCAA Division I Council, as chair of the NCAA Competition Oversight Committee and as a member of the NCAA Division I Baseball Committee, in addition to several other leadership groups.

On a league level, Barnhart – the longest-tenured athletics director in the conference – was named chair of the SEC Athletics Directors in 2017. Barnhart's legacy at UK includes helping develop administrators who have gone on to become athletics directors at nationally prominent universities, including Greg Byrne of Alabama, Mark Coyle at Minnesota, Rob Mullens at Oregon, Scott Stricklin at Florida, John Cohen at Mississippi State and Kevin Saal at Murray State.

Barnhart arrived at UK from Oregon State, where he served four successful years as athletics director. Before OSU, he worked in athletics administration posts at Tennessee, Southern Methodist University, Oregon and San Diego State. Barnhart is a native of Kansas City, Kansas. He earned his bachelor's degree from Ottawa University (Kansas) in 1981 and a master's in sports administration from Ohio University.

An avid mountain climber, Barnhart has scaled Mount Kilimanjaro, along with Mount Rainier in Washington and the Grand Tetons in Wyoming.
